Local sales/use tax changes

(Effective July 1, 2025)

City of Stevenson

Sales and use tax within the City of Stevenson will increase three-tenths of one percent (.003). The tax will be used for transportation services.

San Juan County

Sales and use tax within San Juan County will decrease fifteen one hundredths of one percent (0.0015) to comply with initial imposition of the Emergency Communication Tax. The remaining five one hundredth of one percent (0.0005) of tax will be used for emergency communication systems and facilities.
